Mayor Bevens opened the meeting at 6:30 pm. with the Pledge of Allegiance.

The mayor opened the Public Hearing on the tentative budget for discussion with the Trustees. He stated that he was able to keep the budget under the tax cap and that we would meet again on April 28, 2025 for another budget meeting. The Board of Trustees thanked the mayor for all his hard work on the budget. With no questions from the Board, the mayor asked to close the Public Hearing at 6:35 pm.

Resolution #89- was made by Trustee Eleby to close the Public Hearing on the Tentative Budget at 6:35 pm, seconded by Trustee Carter. All in favor, none opposed, motion carried.

The Board moved forward with the Organizational meeting at 6:36 pm.

Resolution #90- was made by Trustee Carter to approve the minutes of March11, 2025, meeting of the Board of Trustees. Trustee Eleby seconded, all in favor, none opposed.

Climate Smart- The Committee will be submitting for reimbursement for the money that was spent on windows and heat pumps for the Wastewater Plant. Also, money that was spent on heat pumps for the Fire Department.

At the April 1, 2025 meeting Peyton Akers and Roman Turek-Catanzano were granted membership to be firefighters of the Valatie Fire Department.
